

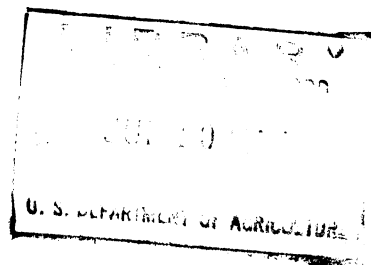

PREFACE

Commodities reported in this summary are outlined in Table of Contents shown below. Shipments shown directly beneath commodity identification in detailed tables are rail shipments moving on initial line-haul waybills, except where the word "Boat" or "BT" is shown directly after the State of origin. The latter are boat shipments of domestic production which moved truck-to-boat. Domestic truck shipments and imports are identified and reported where information was available.

Mixed cars containing as much as 90 percent of one commodity were reported under the name of that commodity. When no single commodity comprised as much as 90 percent, the cars were classified in their proper mixed category; for example, mixed citrus fruit, mixed vegetables. Some divergence from this 90 percent rule may be expected in view of the large number of transportation employees involved in preparation of the reports.

The following abbreviations were used to identify California shipments by districts: MD - Northern District; CD - Central District; SD - Southern District; IV - Imperial Valley.

Imports reported herein were taken from official records of the U.S. Department of Commerce. These data were converted to carlot equivalents on the bases indicated in commodity table footnotes. Segregation of Mexican imports as between eastern and western Mexico origins was not possible because the official data were recorded in total imports of each commodity.

Boat shipments of Oregon and Washington apples, pears, onions and potatoes are not reported. These were included in truck shipments shown in tables.

Footnotes indicating U.S.D.A. Government purchases represent shipments reported as such to the Market News Service by the carriers. This segregation does not necessarily represent complete Government purchase of the reported commodities due to the fact the railroads cannot always readily identify these purchases as such.

Truck shipments expressed in carlot equivalents based upon established conversion factors revised effective January 1, 1950 are included where information was available. The Arizona truck shipments represent only interstate movement. California truck shipments shown as "passings" represent interstate movement; "unloads" represent receipts of California production at Los Angeles, Oakland and San Francisco markets. There were 5503 carlot equivalents of various California vegetables reported in these interstate truck passings for 1955 that were not identified by commodity. These "other vegt." were mostly cabbage, spinach, turnips, green onions, squash, beans, peppers, radishes and other items not specifically identified in commodity tables. Florida truck shipments represent interstate movement plus shipments from peninsula area to west Florida. Texas truck shipments largely represent movement from the Rio Grande Valley.

Cooperation on the part of railroad, express and steamship agents, and officials of State Departments of Agriculture and farmers' markets in furnishing information, as well as members of the produce industry in furnishing records of motortruck movement, is hereby gratefully acknowledged.
